Glossary

VOLAG: Voluntary Agency. There are national VOLAGS and local VOLAGS. Only VOLAGS have an agreement with the U.S. Department of State to receive and resettle refugees.

Refugee Service Provider: Community and faith-based organizations, mutual assistance associations, educational institutions as well as VOLAGS.

Who is eligible for services?

All services are available to refugees, asylees, Cuban/Haitian entrants, victims of trafficking, and Special Immigrant Visa holders from Iraq and Afghanistan. URM services are also available to children with Special Immigrant Juvenile status and U status recipients.

In order to be eligible for Refugee Cash Assistance or Refugee Medical Assistance, participants must be determined ineligible for TANF or Medicaid respectively.

Who provides services?	The U.S. Department of State funds national Voluntary Agencies (VOLAGs) who then allocate funds to their affiliate offices as refugees are placed. Service providers include community and faith-based organizations as well as Voluntary Agencies.	

*Reception & Placement Services (R&P) are only available to refugees and Special Immigrant Visa holders from Iraq & Afghanistan. Other Asylees, Victims of Trafficking, and Cuban/Haitian Entrants are not eligible for R&P services.
