And that brings us to the second concern—the Process. We, the people of the great State of Texas, need you, our elected leaders, to be utterly transparent about the data you use to create these maps. We need you to explain why the changes result in better representation of actual communities—both the physical neighborhoods and precincts, and the communities knit together by common needs.

A fair and open Process like this takes time. More time than is being allowed. I would suggest that the drawing of these redistricting maps every ten years is the single most important activity taken on by the House and Senate each decade. All else follows from the districts drawn on these maps. These are not just lines on a page—these maps control the volume of the voices of the people. Without fair and representative maps, there is no fair or representative vote.
