## AROUND THE STATE

### SUNSET ADVISORY COMMISSION

In January, Lieutenant Governor Dan Patrick appointed me to serve on the Sunset Advisory Commission. Members of the Commission are appointed by the Lieutenant Governor and Speaker of the House and include five senators, five representatives, and two members of the public.

The Texas Legislature created the Sunset process in 1977 to review the need for and the effectiveness of state agencies and their programs. If an agency and its programs are no longer deemed relevant, then the process of Sunset is to recommend abolishing the agency or transferring its functions to another agency with related functions. If an agency and its programs are deemed relevant, then Sunset recommendations will include opportunities for making them more effective and more efficient. Most agencies are reviewed every 12 years.

I am incredibly honored to have an opportunity to serve my fellow Texans on the Sunset Advisory Commission as we work to maximize excellence, efficiency and effectiveness in our state government.

Natural Resources and Economic Development Committee and Water and Rural Affairs Committee joint committee hearing



On January 22, the Senate Natural Resources and Economic Development Committee, of which I am a committee member, and the Senate Water and Rural Affairs Committee met jointly for a committee hearing to discuss the future water supply of Texas and the groundwater regulatory framework in Texas. Both of these topics are very important to our state to ensure we have an adequate supply of fresh, clean water for drinking and municipal use and also a supply for commercial use.

In the 1950s, Texas experienced what has been called the "drought of record." This drought occurred statewide over a series of years. In response, the legislature created the Texas Water Development Board to develop a state water plan and begin investing in critical infrastructure to meet future water needs. Since then, the state water plan has changed from a top down approach to a bottom up approach to allow regions of Texas to estimate population changes, evaluate current and future municipal, agriculture, and commercial uses and

determine water projects that can be used to meet those demands. The state water plan is updated every five years by the Texas Water Development Board working with the local Regional Water Planning Groups. The voters have also approved constitutional amendments, as passed by the legislature, to allow for financing of water infrastructure and supply projects that are included in the state water plan.

For the purposes of the state water plan, the population of Texas and the projected annual water use are projected for fifty years out so the regions can determine projects that are important to meeting the regional water needs. The state water plan must also consider water conservation, expanded use of existing supplies, new supplies, reuse of wastewater, interbasin transfers of surface water, desalination, and aquifer storage and recovery.

The recent committee hearing in January was very informative about the water planning process and how the legislature sets the policies and funding mechanisms in place that govern the water planning process. With North Texas' population continuing to grow, our water planning for future water use, future water supply, and future water conservation is very important.

## DRIVER LICENSE RENEWAL

Several of you have contacted me about the unacceptable wait times at your local Driver License Office. I, too, have experienced this frustration and am committed to work towards resolving this issue.

Last legislative session, my colleagues and I allocated an additional \$200 million to the Texas Department of Public Safety to provide relief to Texans seeking or renewing a driver license. I along with other members of the Collin County delegation recently sent a letter to DPS to better understand how they are utilizing these resources, since the problem of long wait times has not been resolved. I have also requested an interim study to explore efficiency options to provide quality customer service in driver license offices across Texas.

The Department of Public Safety shared with me statistics for Senate District 8 showing that 40% of the individuals who renew their driver license can do so online at [www.texas.gov](http://www.texas.gov) in only 5-10 minutes and a few clicks of a mouse.

So, before waiting in line, please check online to see if you are able to renew your driver license, change the address on your driver license, replace a lost or stolen card, or view and change your emergency contacts.
