STATE OF TEXAS UPDATES

Governor's Executive Order

Governor Greg Abbott issued an executive order on July 2, 2020 requiring people across Texas over the age of 10 to wear a covering over the nose and mouth in all public places for all counties with more than 20 positive cases of COVID-19, which includes Collin, Dallas, Denton, and Tarrant counties.

There are exceptions to the face covering requirement, which includes any person who has a medical condition or disability that prevents wearing a face mask, recreation activities for the purpose of exercising outdoors, swimming in a pool, lake, or other body of water, driving alone or with people who are in the same household as the driver, or eating at a restaurant. No one can be jailed for non-compliance, but they may be fined.

Of note, this does not apply to churches.

The governor also [extended the disaster declaration](#) to prohibit outdoor gatherings of 10 or more people and require them to socially distance at least six feet apart. These gatherings are "prohibited unless the mayor of the city in which the gathering is held, or the county judge in the case of a gathering in an unincorporated area, approves the gathering, and such approval can be made subject to certain conditions or restrictions not inconsistent with the executive order."

Texas Education Agency Guidelines for the 2020-21 School Year

The Texas Education Agency issued [comprehensive guidelines](#) for on-campus instruction for the 2020-2021 school year. These guidelines include the following:

- Provide for daily on-campus learning for all students. Students are still required to meet 90% attendance requirement (some exceptions apply) in order to promote to the next grade level.
- Provide a remote learning option for families at the beginning of the school year or at any point as the year progresses. Families choosing this option may be asked to commit to remote instruction for a full grading period (6

weeks or 9 weeks), but will not have to make a commitment more than two weeks in advance.

- Implement certain health and safety procedures, including screening, for all students, teachers, staff, and visitors to each campus. Schools will also be required to follow any forthcoming executive orders issued by the Governor.

Additionally, TEA is providing districts with resources including reimbursement for COVID-19 related expenses, PPE equipment and supplies, online TEKS-aligned learning tools, and teacher training at no cost to the school system.

Texas Armed Service Scholarship Program

TASSP is a program created by the Legislature in 2009 to encourage students to complete a baccalaureate degree and become a commissioned member of the Texas Army National Guard, Texas Air National Guard, Texas State Guard, U.S. Coast Guard, or U.S. Merchant Marine or become a commissioned officer in any branch of the U.S. armed services. Each legislative office has the opportunity to award a single scholarship each year for a college student who is in an ROTC program and meets the academic performance requirement.

- Texas has 210,585 confirmed cases of COVID-19 out of 2,471,029 tests. An estimated 108,485 individuals have recovered.
- There are 3,707 confirmed cases of COVID-19 involving Collin County residents out of 52,850 tests. An estimated 2,758 individuals have recovered.
- There are 27,054 confirmed cases of COVID-19 involving Dallas County residents out of 208,058 tests. An estimated 15,367 individuals have recovered.
