Dear Ms. Parks and Ms. McGrath:

In accordance with *Rider 18 – Additional Funds* of the Texas Department of Transportation's (TxDOT) bill pattern (General Appropriations Act, Senate Bill 1, 83rd Legislature, Regular Session), we request a \$250 million additional appropriation in our Strategy C.1.2., New Maintenance Contracts, from vehicle registration fees received above the amounts estimated for the Fiscal Year (FY) 2012 – 2013 biennium in order to repair the attached roadways that have been impacted by energy sector activity.

TxDOT is committed to continuing to work with all of our stakeholders and as part of these efforts we will: (1) hold a public hearing at least sixty days prior to the possible conversion of any state roadway not already identified as a candidate for being converted to high-end unpaved surface; (2) reflect in our Unified Transportation Program (UTP) when any such converted roads are anticipated to be converted back to a paved surface based on anticipated available funding levels; and (3) make presentations on the UTP process and document to pertinent legislative committees and interested members.
