Texas Community Based Medicaid Waiver Programs:

Home and Community Based Services (HCS)

Texans of all ages with a primary diagnosis of mental Retardation

Community Living Assistance and Support Services (CLASS)

Texans of all ages with a developmental disability (these individuals will not have a primary diagnosis of mental retardation)

Medically Dependent Children's Programs (MDCP)

Texans ages 21 and under who are medically dependant

Community Based Alternatives (CBA)

Texans ages 21 and older who qualify for nursing facility care

Deaf-Blind Multiple Disabilities (DBMD)

Texans ages 21 and older who are deaf, blind and have a third developmental disability
